### **BELANGRIKE KENNISGEWING RAKENDE SAWIS 7-OPGAWE**

Internasionale handelsdatabasisse soos Trade Map, ComTrade, SARS Doeane, asook marknavorsers soos die IWSR, Wine Intelligence, Euromonitor, MIBD, en AC Nielsen beskou die Suider-Afrikaanse Doeane-unie lande, Botswana, Lesotho, Namibië en Eswatini (Swaziland) (die BLNS-lande), as uitvoerlande vir alkoholiese produkte.

Die SA Wynbedryf beskou tans hierdie lande steeds as deel van binnelandse verkope, maar ten einde beplanning en besluitneming te vergemaklik is daar besluit om hierdie verkope afsonderlik vas te lê en te rapporteer. Dit sal ook vergelykings met bogenoemde databasisse vergemaklik.

Om uitvoering aan hierdie besluit te gee, is die bestaande SAWIS 7-vorm gewysig om spesifiek na die BLNS-lande te verwys.

Ons wil u vriendelik versoek om

1. die SAWIS 7-vorm – **SLEGS BLNS-LANDE** - BINNELANDSE VERPAKTE WYN VERKOOP DEUR WYNPRODUSENT / -HANDELAAR terugwerkend vanaf 1 Januarie 2020 vir ons te voltooi en deur te stuur. Hierdie spesifieke vorm kan ook van ons webtuiste by hierdie [skakel](#) afgelaai word.
2. met ingang van 1 Junie 2020 twee afsonderlike opgawes in te dien: een vir RSA Binnelandse verkope en een vir slegs BLNS-lande Binnelandse verkope.

By voorbaat dankie vir u samewerking in die verband. Skakel gerus met skrywer indien enige daar enige onduidelikhede is.

### **IMPORTANT NOTICE REGARDING SAWIS 7 RETURN**

International trade databases such as Trade Map, ComTrade, SARS Customs, as well as market researchers such as the IWSR, Wine Intelligence, Euromonitor, MIBD and AC Nielsen consider the Southern African Customs Union countries Botswana, Lesotho, Namibia and Eswatini (Swaziland) (the BLNS countries) as exporting countries for alcoholic products.

The SA Wine Industry currently considers these countries as part of domestic sales, but to assist with planning and decision-making, it was decided to record and report these sales separately. It will also facilitate comparisons with the above-mentioned databases.

To fulfil this request, the existing SAWIS 7 form was amended to make specific reference to the BLNS countries.

We therefore request you to

1. submit the SAWIS 7 form - **BLNS COUNTRIES ONLY - DOMESTIC PACKAGED WINE SOLD BY WINE PRODUCER / - TRADER** retrospectively from 1 January 2020. This specific form can also be downloaded from our website at this [link](#).
2. submit as of June 1, 2020, two separate returns: one for RSA Domestic Sales and one for BLNS Countries only Domestic Sales.
